



Intro

ocated in the heart of Southeast
Asia, the Philippines is a wonderful
archipelago composed of over 7.000
islands, each with its own unique

Hikers from all over the world flock to the Philippine mountains in search of breath-taking views and exciting adventures in the fascinating landscapes of this asian republic.

Besides, its rich history, shaped by indigenous tribes, Spanish colonization and American influence, is evident in its colourful festivals, delicious cuisine and UNESCO World Heritage Sites.

From the vibrant street art scene in the bustling neighbourhoods of Manila to the ancient rice terraces in the Cordillera Mountains, the Philippines offers a rich tapestry of experiences waiting to be explored.







Luzon

mong the archipelago islands, Luzon stands out as the largest one, unfolding as a captivating mosaic of landscapes and cultural treasures.

Located in the western Pacific, this island is the country's economic and political hub, home to the bustling metropolis of Manila and Quezon City, as well as other numerous vibrant urban centres.

With a population of 64 million, it contains 52.5% of the country's total inhabitants and is the fourth most populous island in the world.

Incredibly various in terms of heritage and inhabited by various ethnic groups and communities with their own traditions, languages and customs, Luzon is a place that encompasses a wide diversity of cultures that contribute to the richness of the Filipino identity.

Beyond the modern cityscapes and the urban sprawl around the capital city, this island unfolds with a spectacular natural beauty where mountain ranges covered in tropical vegetation and extensive terraced rice fields become the most prominent protagonists of the panorama.



The Cordillera Central

nown as the biggest and highest mountain chain in the Philippines, measuring 320 km long north to south and 118 km width east to west, the Cordillera Central comprises about one sixth of the whole surface of Luzon.

This mountain range not only shapes the topography of the island but also affects its climatic pattern, as it acts as a barrier against the north-eastern and southwest monsoons, as well as against cyclones that seasonally cross the territory.

Apart from its environmental relevance, the Cordillera Central is one of the richest regions of the country in terms of natural resources and, therefore, an important income base of the Philippines.

Over 11% of the total area is occupied by agricultural rice fields, orchards, pig farms and pasture lands.

Characterised by steep slopes, deep valleys and terraced rice fields carved into mountainsides, this rugged context witnesses the ingenuity of local communities in adapting to such challenging terrain.

The so called "Cordilleran Culture" has been not only largely shaped by the geography of the mountain range but it also reflects a common heritage of resistance to invading imperial powers, including continued adverse invasions of the lowlands.

Famous for its stunning landscapes and rich biodiversity, the Cordillera Central plays a crucial role in the country's cultural and historical heritage, as it is home to several indigenous communities like the Ifugao peoples, guardians of the UNESCO World Heritage Site known as the Banaue Rice Terraces.







Ifugao

mmersed in the rugged landscapes of the Cordillera, the Ifugao community thrive in between stunning landscapes and ancient customs. Long recognised for their unique culture, rich traditions and unique agricultural practices, they have a history that spans over two thousand years, with their roots traced back to the precolonial era.

In the heart of their ancestral lands, Ifugao villages dot the verdant hillsides, each a testament to their deep connection with the natural world.

Traditional houses, crafted from indigenous materials like wood and thatch, blend seamlessly with the surrounding landscape, reflecting their harmonious relationship with nature. Within these villages, the rhythms of daily life are punctuated by rituals and ceremonies that honour the spirits of the land and ensure the prosperity of their crops.

In fact, the Ifugao are renowned for their mastery of agriculture and for having sculpted the mountainsides into a mesmerizing tapestry of terraced rice paddies that cascade down the slopes like emerald staircases. These terraces - a UNESCO World Heritage Site - sustain not only their livelihood but also their cultural identity, serving as the lifeblood of their community.



Banaue Lodge

he majestic Banaue Rice Terraces, a unique landscape shaped by the hand of man over the centuries and home to the Ifugao peoples, today has become one of the favourite destinations of thousands of backpackers in search of an authentic adventure.

Often referred to as the "Eighth Wonder of the World" these terraces, crafted without modern tools, represent an engineering marvel, showcasing the Ifugao's mastery of sustainable farming practices.

For hikers, this magnificent scenery offers an unparalleled trekking experience through lush greenery and terraced fields that stretch as far as the eye can see. Trails wind through picturesque villages where travellers can interact with locals, witnessing traditional farming techniques passed down through generations.

"Banaue Lodge" is an architecture competition that aims to design small scale accommodation structures that allow the most curious explorers to immerse themselves in a 360-degree experience. A privileged stopover for those courageous tourists who seek a deeper connection with nature and culture.

Whether watching the sunrise from the terraces or attending the timeless rituals of the Ifugao people, this competition is about imagining a place where visitors can live an authentic adventure immersed in this fantastic site.







The Competition

ith the idea of promoting a kind of slow and sustainable tourism, capable not only of respecting local traditions but also of quaranteeing care for the environment, this competition encourages participants to design a type of accommodation that fits perfectly into the context of the Banaue Rice Terraces.

Currently, there are only a couple of small sleeping structures within the Batad village that accommodate overnight tourists.

The idea is to complement these existing services, providing an alternative option for backpackers intent to spend the night and to foster meaningful connections with the local community.

Whether it is sharing a meal with a local family, learning about indigenous farming practices or joining community-led tours, these immersive experiences will offer a deeper understanding of the region's heritage and way of life

The key is to analyse the landscape, the local materials, colours and textures, in order to translate the most significant characteristics into essential architectures able to enhance the natural context.

Contestants are therefore asked to envision creative proposals focused on a unique and unconventional type of lodging structure capable of redefining accommodation options for hikers.

The essence of the "Banaue Lodge" contest lies in its emphasis on harmonising architectural design with the breath-taking beauty of the terraces of Batad.

By incorporating sustainable materials, local construction techniques and efficient design solutions, the envisioned cabins will serve as models of environmentally responsible tourism development.



The Project

n the pursuit of innovative ideas, this competition aims at encouraging participants to explore various architectural concepts and layouts. The general program is based on the design of cabins capable of accommodating those adventurous tourists who intend to live an immersive experience on the site.

The project itself must be located on a specific plot within the Batad village that will be indicated in the contest's download package.

The primary objective is to steer clear of large-scale constructions that often disregard the local environment. Instead, the focus is on crafting modest-sized structures that enhance the natural beauty of the area and seamlessly integrate with the existing natural and built surroundings.

The harmonious interaction between the new facilities and the existing landscape is crucial and requires meticulous attention.

Accommodation should be guaranteed to a range of six to eight guests maximum, and rooms can be housed within a single block, separate units or even small independent structures isolated from one another.

It is therefore up to each designer to decide how to distribute the elements: both the most compact proposals and those more dispersed on the site will be equally considered.

Likewise, total freedom will be left when deciding the square meters to cover, the floors and the height of the volumes: be sensitive and ensure that your project integrates into the context!

The intention is not to design an elegant boutique hotel, but rather a functional, minimal and essential structure that harmoniously merges with the setting and existing buildings.

Every room must have access to shared bathroom facilities, as well as a minimum storage space. Additionally, intermediate and outdoor areas may be included for exclusive or communal use, providing guests with opportunities to immerse themselves in the serene atmosphere and share activities with the locals.

Batad's environmental conditions, including heavy rainfall and exposure to natural elements, require resilient and weather resistant design elements. Participants are expected to incorporate materials and design features that withstand the local climate, ensuring durability and low maintenance.

Finally, do not forget the panoramic location of the site and make sure to capture the magnificent views through your project!







Evaluation Criteria

The jury will evaluate all the proposals according to the following principles:

- Originality of the concept;
- Integration with the natural context;
- Creative interpretation of the program;
- Sensitive use of materials and textures;
- Environmental impact;
- Graphic representation;

Projects that express a special sensitivity towards landscape design and quality architectural solutions will be highly appreciated.

Reaching deep technical-constructive details will not be considered extremely important in the evaluation process.

A complete package with all the documentation regarding the site (photos, maps, dwg drawings) will be available for all participants on Terraviva website.



Terms & Conditions

- A. The competitions are open to students, architects, designers, urbanists, engineers, artists, makers, activists and anyone interested in the design and architecture fields. The participant must be at least 18 years old;
- B. Participants can join the competition either individually or in team. There is no restriction or limit to the number of members that can compose a team. Teams can be made up of members of different nationalities and ages, but all members must be at least 18 years old. The list of the team members cannot be changed after the submission;
- C. Participants must respect deadlines, procedures, fees and submission requirements. It is highly advised to complete any of these online procedures (also registration) in advance. TerraViva S.r.l. is not responsible, in any case, for any technical difficulty or web malfunctioning;
- D. All the necessary materials/documentation related to the competition is available in the download section of the competition's official page. to download and use the materials/documentation of the competition made available by TerraViva S.r.l. it is necessary to pay a registration fee, which allows to get a single identification code.
